Kristi House is dedicated to treating and preventing child sexual abuse, trafficking and other childhood trauma, working closely with community partners, parents and providers.

Child Trauma Experts

Kristi House provides children and their families with proven, evidence-based mental health interventions and wraparound services which enable them to get past the trauma and go on with their lives. In most cases, children and youth who complete treatment with Kristi House emerge stronger than ever.

Unique in Miami-Dade

Operating the nationally accredited Children's Advocacy Center responsible for all of Miami-Dade County, Kristi House is the only facility dedicated to a mission of system coordination to ensure that all emotional, physical and legal needs for child sexual abuse and teen sexual assault victims are provided. Every week partner-agencies — including medical staff, guardians, social service investigators, police, prosecutors, therapists and case workers — meet to discuss individual cases to make certain that no child falls through the gaps in our complex systems of care and justice. All services are provided at no charge to victims and families.

Wraparound Support for Healing

In addition to coordinating the Kristi House Children's Advocacy Center Multidisciplinary Team, we provide the specialists to help the child and family heal. Our direct services staff includes engagement specialists, care coordinators and master level and licensed Therapists trained in the most effective interventions for recovery.

Restoring Lives

Kristi House additionally treats many forms of mental health trauma with evidence-based modalities and best-in-class services from a team of experts. In the past 29 years, Kristi House has treated 28,200 children, trained 157,000+ individuals, and expanded to five locations. Beyond the numbers, thousands of lives have been restored, putting the trauma of abuse behind.
